a) **Phase II lights** *Nancy reported that bids are being considered. A solar option for a power source is being researched to compare costs.*

*Phase I electrical cost payments will be paid quarterly for the 2 Phase I host businesses and has been coordinated with Ann Marie and Tonya.*

b) **METRO meeting** *March 10<sup>th</sup> meeting was successful. The METRO March 25<sup>th</sup> report will reveal how Boulder Creek and SLV will be affected and the next action required.*

f) **Historic sign project** *Tamara reported previously speaking with Lynda Phillips and Lisa Robinson regarding historic signs for the buildings in town. A committee of Tamara, Janet and Doris will work to gather info on the project.*

Ann Marie reports that the renewal date for the event insurance makes the permit process difficult due to the renewal date in May. Doris will address the issue with the new insurance agent. Chris will handle the signage for the event and Nancy will work on an agenda for the event.*
